A \$250 cash deposit is required for the D.I.Y. package. First, a \$100 deposit is required to hold your date. Then, when picking up the fountain, an additional \$150 cash will be collected, to total the \$250 deposit. The rental fee and any additional fees will be deducted from the deposit, and the remaining amount will be refunded upon return of the fountain. The fountain must be returned and checked in by Lady Belgium before refunds are given.

The D.I.Y. package is a 24 hour rental. You are responsible for PICKING UP THE MACHINE, SETTING UP AND RUNNING IT AT YOUR EVENT, CLEANING THE FOUNTAIN, AND RETURNING IT TO LADY BELGIUM CHOCOLATE FOUNTAINS. Special arrangements may be made for returning the fountain, *before* picking up said machine.

INCLUDED IN RENTAL ARE:

- Chocolate:

6 lbs Premium Chocolate* – Additional chocolate may be purchased for \$6.00/lb. (Sold in 2-pound packs; 1 lb. serves about 10 people)

**To upgrade to Belgian chocolate, add \$20 to the rental price. Additional Belgian chocolate may be purchased for \$8.00/lb. (Sold in 2-pound packs)*

- Rental Time:

- 24 hours (D.I.Y. package) – Additional time will be billed at \$12.50 per ½ hour, unless other arrangements are made with Lady Belgium, before picking up the machine.

Payment terms: Total fee agreed upon by Client and Lady Belgium Chocolate Fountains is:

_____. Lady Belgium Chocolate Fountains is holding a tentative reservation for Client's event until 5 days after the below "Contract date." To confirm agreement, return one signed and completed copy of this contract along with a deposit of \$100.00 within 5 days. (Personal checks will be accepted for the deposit, IF received at least 10 business days prior to the rental date.) Agreements received after 5 days from the contract date are subject to availability.

The balance is due no later than 7 days prior to the date of the event and must be paid in cash, money order or cashier's check. Checks & money orders should be made payable to Jenny Blake (Owner of Lady Belgium Chocolate Fountains). Any personal checks used for initial deposit are subject to \$30 fee if returned by your bank and must be drawn on local banks only. Any unpaid balances must be paid prior to the date of the event. Fees for any additional chocolate or rental time requested at the time of pick-up are due at that time.

Cancellation: If cancellation is initiated by the Client then the deposit will be forfeited. The liability of Lady Belgium Chocolate Fountains to perform said services is subject to proven detention by sickness, accidents or any other actions not under its control. Any monies paid will be returned in full if Lady Belgium Chocolate Fountains suffers sickness, accident or other actions not under their control.

Provisions: Client is responsible for providing a sturdy, level table capable of supporting the running fountain. Also required: one, 120 volt circuit within 10 feet of the desired set up area. Please, no air conditioning vents or fans blowing on fountain area. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions.

Liability: This agreement and the contents hereof represents the only warranties, express or implied, between the parties, including any implied warranty or merchantability of fitness for the particular purpose and for any other obligation or liability on the part of Lady Belgium Chocolate Fountains. Lady Belgium Chocolate Fountains shall not be liable for any injury, loss or damage directly or consequently arising out of the use or inability to use the chocolate fountain, whether used singularly or in conjunction with any other equipment. Client will indemnify Lady Belgium Chocolate Fountains against, and hold Lady Belgium Chocolate

Fountains harmless from all claims, actions, proceedings, costs, damages, and liabilities, including attorney fees, arising out of, connected with, or resulting from the use of the chocolate fountain.
